

Terms and Conditions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Disclaimer:

Company (referred to as either "the Company", "We", "Us" or "Our" in this Disclaimer) refers to DeCesha Inc dba ForceReadiness.com, 7901 4th St N STE 300, St. Petersburg, FL 33702.

Service refers to FireSync Enterprise™ SaaS, which includes the FireSync CAL, FireSync OPS, and FireSync EMS Applications, and TheHouse™ SaaS.

You means the individual accessing the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.
